Background

Career

Randy held several jobs while in school studying to become an attorney. From 1990 – 1993, he served as Voting Section Paralegal for the US Department of Justice, Civil Rights Division, and Law Clerk for the Public Defender Service for the District of Columbia in Washington DC. In 1993, Randy was a Law Clerk for the Alabama Capital Representation Resource Center, and from 1993 – 1994 while finishing up his JD degree, he served as Student Attorney at the Georgetown University Criminal Justice Clinic.

Since earning his JD degree in 1994, Randy has been Staff Attorney, Senior Attorney, and is currently Deputy Director of Equal Justice Initiative (EJI) in Montgomery, Alabama. EJI is a non-profit organization that provides legal representation to people who have been illegally convicted, unfairly sentenced, or abused in state jails and prisons. Randy represents people sentenced to death and children sentenced to life in prison without possibility of parole. His representation involves trial level and appellate advocacy in both state and federal court, including cases before the United States Supreme Court. He teaches and advises law students and assists lawyers throughout the country in capital litigation. Additionally, he manages several of EJI's public education projects and programs.

Randy resides in New Jersey with his wife, Monique, and their two children, Noah and Alex. They live just outside of New York City where, in addition to working for EJI, he serves as an Adjunct Assistant Professor of Clinical Law at New York University School of Law. Randy frequently provides training, expertise, and consultation on habeas corpus issues and death penalty topics.
